As you know, I am the solicitor for the Town of Erin. Your email and attached letter of April 30, 2021 addressed to His Worship Mayor Alls has been forwarded to the undersigned for reply. I can advise you that during the undertaking of the Municipal Class EA for the proposed Town of Erin Wastewater Treatment Plant, the Town of Erin and its consultants complied with all legal requirements of all levels of government and with the common law with respect to the consultations that are required with Indigenous stakeholders in order to satisfy the honour of the Crown. Communication was sent to The Haudenosaunee Confederacy on several occasions as they were on the contact list approved by the Ministry of the Environment Conservation and Parks. The Haudenosaunee Confederacy was also provided with all notifications sent out with respect to the Class EA including notices of Public Information Centres and Notices of Commencement and of Completion. Telephone contact was also attempted. In addition, as part of the Part II Order, which you initiated, the Minister asked the Town to outline its consultation efforts with all indigenous stakeholders, which we did outline to the Minister. As you are aware, the Minister declined to issue a Part II Order. As a result, the Town will continue to implement the Municipal Class EA.

I trust this answers your questions.
